Settlement: Settlement shall be at the conclusion of the auction, each day of the auction. Successful bidders shall be called to remit payment, in order of their registration and bidder number. Bidders shall immediately remove their property, once payment has been validated.

Property left at the conclusion of the auction shall become property of the Colorado Toy Train Foundation

All items are sold AS IS, WHERE IS, without any Guarantees or warranties, written or implied, or refunds. It is the bidders' responsibility to inspect all items prior to bidding.

All sales are final, once a bid is awarded. There are not any refunds, exchanges, or refusals. All disputes are resolved at the discretion of the auction chair. The winning bidder and the price recorded by the auction clerk on the auction form takes priority and is official.
