A BILL

To designate the area between the intersections of International Drive, Northwest and Van Ness Street, Northwest and International Drive, Northwest and International Place, Northwest in Washington, District of Columbia, as “Li Wenliang Plaza”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF LI WENLIANG PLAZA.**

4 (a) DESIGNATION OF PLAZA.—

5 (1) IN GENERAL.—The area between the inter-
6 sections of International Drive, Northwest and Van

1 Ness Street, Northwest and International Drive,
2 Northwest and International Place, Northwest in
3 Washington, District of Columbia, shall be known
4 and designated as “Li Wenliang Plaza”.

5 (2) REFERENCES.—Any reference in a law,
6 map, regulation, document, paper, or other record of
7 the area referred to in paragraph (1) shall be
8 deemed to be a reference to Li Wenliang Plaza.

9 (b) DESIGNATION OF ADDRESS.—

10 (1) DESIGNATION.—The address of 3505 Inter-
11 national Place, Northwest, Washington, District of
12 Columbia, shall be redesignated as 1 Li Wenliang
13 Plaza.

14 (2) REFERENCES.—Any reference in a law,
15 map, regulation, document, paper, or other record of
16 the United States to the address referred to in para-
17 graph (1) shall be deemed to be a reference to 1 Li
18 Wenliang Plaza.

19 (c) SIGNS.—The Administrator of General Services
20 shall construct street signs that shall—

21 (1) contain the phrase “Li Wenliang Plaza”;

22 (2) be similar in design to the signs used by
23 Washington, District of Columbia, to designate the
24 location of Metro stations; and

25 (3) be placed on—

1 (A) the parcel of Federal property that is
2 closest to 1 Li Wenliang Plaza (as redesignated
3 by subsection (b)); and

4 (B) the street corners of International
5 Drive, Northwest and Van Ness Street, North-
6 west and International Drive, Northwest and
7 International Place, Northwest, Washington,
8 District of Columbia.
